Except for a few details, you will be able to simulate the entire sales process.

These details are:

- Client **first name and last name** cannot be changed to ensure you don't inadvertently use “Sale simulation” with a real client.
- Two payment options are offered at *step 7 / Payment*. In order to avoid a pre-authorized amount being taken from the credit card, we recommend selecting preauthorized debit as the method of payment.
- The application won't be sent to Humania Assurance and **the email confirmation** request will not be sent to the client.

IMPORTANT NOTICE : sales simulations completed or not, will be deleted at the end of the day.

REQUIRED CUSTOMER INFORMATION

As it's an instant application, you will need the following:

- Client's email.
- Valid ID: driver's licence, passport, Health Insurance Card.
- Specimen cheque or credit card.

It is also suggested to have this information:

- Social Insurance Number (SIN)
- Information on attending physician
- List of medication

IMPORTANT : The customer SIN is not mandatory but it allows the MIB to better identify the person thereby tailoring the insurability questions and accelerating the sales process.

COMPLETE THE APPLICATION AT YOUR OWN PACE

Once *step 1 / Coverage* is completed, all entered information will be stored automatically, allowing you to come back later.

Retention periods



- 30 days to complete the application;
- 7 days to complete step 3 | Insurability (from the beginning of this section);
- 3 days for the insured/policyholder to confirm the sale by email.
